#### Eligibility for the Building Level Administrator License (Indiana)

The Urban School Leadership Graduate Certificate BLA licensure program is an approved program by the Indiana Department of Education (IDOE). To obtain a Building Level Administrator license students must successfully complete the program <u>and</u> meet other relevant IDOE requirements including.

- Hold a Proficient Practitioner or Accomplished Practitioner license.
- Pass the ETS Test #5412: Educational Leadership: Administration and Supervision with a score of 150 or higher. Find the link for the ETS Test information here: <a href="https://praxis.ets.org/state-requirements/indiana-tests.html">https://praxis.ets.org/state-requirements/indiana-tests.html</a>
- Valid CPR/AED training at the time of applying for the Building Level Administrator license; here is a list of state approved providers: <u>https://www.in.gov/doe/educators/educator-licensing/cpr-and-aed-certification/</u>

#### **Licensing Application Process**

Applicants that have completed a Building Level Administrator Program may apply online through the License Verification and Information System (LVIS). Note: \*Students may apply after the certificate is posted to the transcript.

- Log-in to the Indiana LVIS Portal and create an individual profile. Be sure to indicate that IU Indianapolis is the "recommending university."

## Application Documents (Domestic Students)-All Application documents should be written in English

- Personal Statement(upload online)- Please use the writing prompts as a guide for your statement. Writing prompts:
  - Are you an Elementary or Secondary Education licensed teacher in Indiana? If so, what license do you hold?
  - What are your personal, academic, and career goals?
  - How will this program help you meet your academic and career goals?
  - What experiences have prepared you for this program?

This statement should be no more than three double-spaced pages, with a 12-point font.

## • Two Letters of Recommendation(upload online)

The letters of recommendation must be professional, on letterhead, and signed. Select recommenders who can attest to and describe your character, skillset, experiences, and abilities.

Please note: The application will require you to submit your recommender's email; an email request will automatically be sent to the recommender on your behalf.

• Transcripts(upload online)

Submit an unofficial transcript for each institution
